Membership Agreement Form

This membership form will lay out the terms and conditions for which the Silver Spade Card Club provides the rights of private, social club membership to the signing member of this form.

1. To be eligible for a membership at Silver Spade, you must be at least 18 years of age with a valid ID. Silver Spade Card Club has the right to accept or reject applicants for membership and restrict membership at any given time.
2. As a member of Silver Spade Card Club, you will have the privilege to participate in club activities such as, but not limited to, card games, food and beverage, special events, and other membership benefits as given by the discretion of the club floor managers.
3. As a member, you agree to pay either the daily, monthly, or yearly entry fee to gain access to the club. These fees are subject to change. Any memberships that have expired must repay the daily, monthly, or yearly fee to regain access and privileges to the club. By signing this form, you agree to pay \$10 to Silver Spade Clubs Inc. to complete your membership. All member time fees and entry fees will be paid in full, by cash or card.
4. All members of Silver Spade must abide by the club rules. By signing this agreement, you, the signing member, agree to follow our club rules. These rules can be found on our website at www.silverspadepoker.com/clubrules
5. The signing member represents and warrants he/she shall not disclose information obtained at the Silver Spade Card Club regarding other members which includes their identities, likenesses, addresses, or any other identifying information. Member warrants that he/she is relying on his/her own judgement plus the judgement of his/her advisors in entering into this agreement. Silver Spade Card Club does not provide advice, legal or otherwise, to prospective members related to this agreement.
6. As a member of Silver Spade Card Club, the signing member accepts the full responsibility for risk of injury or financial loss from participating in club activities and agrees that Silver Spade Card Club is not responsible for risk of injury or financial loss from participating in club activities. Member further agrees that parties to the Silver Spade Card Club including management, dealers, front counter staff, cashiers, general staff, contractors, and club members will not be liable for any personal, children, heirs, or other relatives resulting from negligence, recklessness, disease transfer, or omission, without limitation. To the fullest extent of the law, the signing member forever releases, waives, and discharges parties to the Silver Spade Card Club, their successors, and assigns, from all such claims. Member indemnifies the Silver Spade Card Club and its parties from any costs, losses, damages, and attorney fees which may be incurred in any claim or legal proceeding brought by the member or on the member's behalf. The signing member and the Silver Spade Card Club agree that any award for breach of this agreement is specifically limited to actual damages and that neither party may seek to recover indirect, special, incidental, or consequential damages.
7. Members of the club agree to allow Silver Spade Card Club to take promotional photos for the sole purpose of social media marketing. Any videos, photos, and audio of members captured within the club are the property of Silver Spade Card Club to use for marketing purposes.
8. The signing member and Silver Spade Card Club agree that this statement is governed in accordance with the laws of the state of Texas. All disputes, controversies, or claims arising from this agreement shall be brought in a court of competent jurisdiction in Dallas County, Texas.
9. The signing member grants the Silver Spade Card Club opt-in permission to send promotional emails that include information on special events, promotions, updated policies, and other information periodically. The signing member may unsubscribe at any time via opt-out links in the emails.
